

Largest Lotto 649 Jackpots

Updated December 21, 2020

List of the largest Lotto 649 jackpots to date. Not surprisingly, all of the jackpots occurred after the Lotto 649 went to a \$2 ticket in June 2004. The largest Lotto 649 jackpot, when tickets were \$1, was \$26,410,706 on September 2, 1995. In September 2013, the ticket price was raised to \$3 and jackpot records set with the \$3 priced tickets are indicated in red. See below for an explanation on how the deflator rule works.

Deflator Rule

A predetermined formula is used to calculate how much money from ticket sales is used to fund the jackpot. When a jackpot reaches a certain large level, some lottery companies decrease the amount of money used to fund the jackpot in order to decrease the growth of the jackpot. The decreased amount is used to fund the lower tier prizes. This rule is called the jackpot deflator rule. With the deflator rule, the same total amount of money is paid out in prizes, it is only distributed differently. The deflator rule was used in the past for the Lotto 649 game.
